Mare Reproductive Contract – Between Goulburn Valley Equine Hospital (GVEH) of 905B Goulburn Valley HWY, Congupna VIC 3633 AND The Mare Owner/Mare lessee.

The Mare Owner: Every owner, lessee, syndicate, corporation, trust, other person or manager of any of them and where there is more than one person these terms and conditions will bind all such owners jointly and each of them separately.

In the event that this agreement is executed by an agent or Manager on behalf of the mare Owner, or a representative or principle on behalf of the Owner. If the Owner is an organisation, the undersigned agent, representative or principle hereby unconditionally guarantees the full and prompt payment of the fees as well as the full and prompt performance by the Owner of any and all other obligations.

GVEH has agreed to supply veterinary services to the Mare owned by the Mare Owner upon the following terms and conditions:

1. Term
 - 1.1 The contract will be valid during the current breeding season or until the mare is 45 days pregnant (the Term).
 - 1.2 Mares starting reproductive veterinary work must have properly executed this contract and received by GVEH prior to the initiation of reproductive work.
2. Charges
 - 2.1 Once this Contract is executed by the Mare Owner/Mare lessee it is binding and the full fee for services set out in clause 2.2 is payable (even if the Mare achieves a positive pregnancy on the first cycle as per respective breeding contract or fails to obtain pregnancy during the Term).
 - 2.2 The fee for the services for the Term of the Mare Reproductive Contract shall include a **\$1000.00 deposit** prior to the arrival of the Mare.
 - 2.3 The Mare owner(s) agree to pay all accounts within 30 days.
 - 2.4 The Mare owner(s) agree to pay the storage fee for any frozen semen allocated to the mare that remains at GVEH after the breeding term.
3. Services to be supplied by GVEH
 - 3.1 GVEH will undertake the routine veterinary work during the Term following accepted payment of services.
 - 3.2 The Mare Owner irrevocably appoints and authorises the manager of the Property where the Mare is resident or agisted to direct and authorise GVEH to undertake, without limitation, any and all veterinary treatment in respect to the Mare and its progeny. If this veterinary treatment falls outside the scope of this Mare Reproductive Contract, but in the opinion of the Property manager is necessary, GVEH will carry out this veterinary treatment at the owner's expense. The owner acknowledges liability for these additional veterinary costs. In the event that you cannot be contacted regarding treatment or unforeseen problems GVEH will treat as necessary. Every effort will be made to advise you prior to treatment.
 - 3.3 Any costs will be billed to the client. Full payment is expected before your mare departs GVEH.
4. Hold Blameless
The Mare Owner acknowledges that:
 - 4.1 The breeding and rearing of mares is high-risk and that the owner has the option to insure against such losses.
 - 4.2 Per-rectal examination and ultrasonography are important in the reproductive management of the mare but carry a small risk of inadvertent serious injury with a potential sequela of death.
 - 4.3 Multiple pregnancies are possible in the mare and are routinely managed by early identification and termination of one developing pregnancy. This procedure is routine but will occasionally result in termination of both pregnancies. GVEH is hereby and specifically authorised and instructed by the Mare Owner to undertake reduction to a single pregnancy.
 - 4.4 The Mare Owner accepts the risks in the procedures described in 4.2, 4.3
5. The Mare Owner
 - 5.1 The Mare Owner hereby warrants, covenants and agrees with GVEH:
 - That the Mare owner is the registered Owner of the Mare with full power and authority to enter into each of the provisions of the agreement.
 - The mare Owner has disclosed all relevant veterinary and breeding history of the Mare which are relevant to the reproductive and treatment history of the Mare.
 - 5.2 The Mare Owner shall be solely responsible for all insurance arrangements of the Mare of its progeny.
 - 5.3 The Mare Owner confirms that attendance upon delivery of the Mare by GVEH it is free from disease or infection and that all vaccinations are up to date.
6. Retention
Without limiting GVEH's rights in respect of a lien or power of attorney, GVEH shall be entitled to retain possession of the Mare, it's progeny, stored semen, covering certificates or any other documents of description until all payment due and owing have been received from the Mare owner.

Mares for Embryo Transfer

Payment of the recipient mare lease is due and payable on 45-day pregnancy test. The fee of the recipient mare includes all drugs and pregnancy scans due, up to and including the 45-day pregnancy scan. Agistment will be charged at \$18.00 per day for the recipient after 45-day pregnancy scan and billed to your account. Any treatment the recipient mare may require after the 45-day positive scan will be discussed.

It is the client's responsibility to arrange transport for the recipient mare once the mare has been scanned 45 days in foal. Please notify the Reproduction Department a minimum of 24 hours before you have the recipient mare collected, if she is being collected on the weekend, please call on the Thursday before the weekend so that we can have her ready for departure.

It is the client's responsibility to take care of the recipient mare and return her to Goulburn Valley Equine Hospital. Unless otherwise arranged, the recipient mare will only be returned between July and September after the foal has been weaned. The cost of transport to and from GVEH for the recipient mare is the owner of the embryo's responsibility. The client is responsible for any agistment that the recipient mare may incur while away from GVEH. Please notify the office if the mare is ill, injured or loses the pregnancy or the foal dies. If the recipient mare contracts strangles, ringworm or any contagious diseases please notify the office. If the recipient mare is severely injured or dies, a vet certificate must be supplied to Goulburn Valley Equine Hospital or a non-return fee will be charged to your account. The recipient mare must be returned in an acceptable condition.

GVEH will not be held responsible for any accounts payable for vet bills, transport or agistment due for the recipient mare during the lease period, this is the responsibility of the donor mare's owner or person leasing the donor mare.
